

EMD Exemption is allowed to bidder having MSME certificate certified and inspected by any state/central government organization.

The Bidder / OEM must Be Uploaded All technical details should be attached with brochure/ catalog and drawing, Time of Completion Bar Chart (as per specification).

The Bidder / OEM should be registered with Udyam registration which is to be attached with the bid documents.

The Bidder / OEM should be attached PAN, GST Registration Copy and the last month GST filling documents Last three financial years ITR , Profit And Loss Account, Balance Sheet.& 5 years of Turn Over certificate approved by CA. OEM/Bidder Should have achieved minimum 1 crore Annual Financial turnover ( in Gate/Iron fabrication/related products)in any one of the last 3 Financial years. .Profit and Loss: Bidder should not incurred losses in ANY OF Last 3 FY years ending FY 22-23 .

The Bidder / OEM {themselves or through reseller(s)}, should have executed project for supply and installation / Commissioning of in Gate/Iron fabrication/related products in last 3 financial years (i.e. current year and Two previous financial years) as on opening of bid, as per following criteria:

(i) Single order of at least 80% of estimated bid value; or

Satisfactory Performance certificate / Work completion certificate issued by respective Buyer Organization for the above Orders should be uploaded with bid. In case of bunch bids, the Category related to primary product having highest bid value should meet this criterion

OEM/Bidder Valid GREEN GUARD, ISO 9001, 50001 & 45001 ISSUED from IAF/NABCB accredited agencies, OEM/BIDDER should be member/compliance of BIFMA & IGBC from last three years, AIOTA & Trade Mark & trade license Certificates,solvency certificate(minimum 50 lakh) & Character Certificate Must Be Attached Along With the Bid.

OEM Must Have Active Service Center and Local Service Executive In Bihar Details To Be Submitted.

OEM/Bidder must have Order copy of Government institutes, or any other state or central govt. institutes or entities. for supply of same or similar item must be attached along with the bid.

Bidders must have to Deposited the Physical copy of EMD after bidder have submitted the Bid with in Two Days.

100% Payment Will Be Done After Successful Delivery & Installation/Demonstration To Destination.

Bidder's Offer Is Liable To Be Rejected If They Don't Upload Any Of The Certificates/Documents Sought In The Bid Document And Corrigendum If Any.

Competent Authority reserves the right to cancel the bid at any stage without assigning any reason thereof before placing order.

Bidder must not be blacklisted in any states in past 5 financial years. Affidavit must be attached along with the bid.

L1 Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. L1 Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of financial bid opening. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with Modifications as communicated by Buyer.
